- Exhibitors are required to be open for business between 10:00 am and 3:00 pm. Exhibits are not to be dismantled before 3:00 pm. **No exceptions! (Any vendor leaving their designated space before 3:00 pm will not be allowed to participate the following year)**
- All vehicles must be removed from the show area by 9:00 am. A city parking lot near the show area will be reserved for exhibitor parking.
- **ALL FOOD VENDORS:** Please contact the Sampson County Environmental Health office at (910) 592-4675 to verify whether or not you will need a temporary food permit.
- **NO GENERATORS, of any kind, will be allowed!**
